

Per your instructions this is the letter you requested to verify Unique Paytelephone's mailing address.

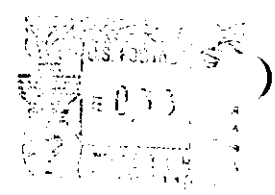
