However, pursuant to Section 350.113(4), Florida Statutes, the Commission shall provide at least a 45 days notice of the date the payment is due prior to the due date. A.M.A. was scheduled to remit its RAFs by February 1, 1999.

On September 27, 1999, Mr. Armando Abad, President of A.M.A., contacted our staff and advised that A.M.A. would pay the past due amount and would make a settlement offer. At the October 5, 1999, Agenda Conference, we voted to cancel A.M.A.'s certificate unless it paid a \$500 fine and the past due fees. On this same date, A.M.A. paid the past due amount in full and proposed to contribute \$100 to the State General Revenue Fund and to pay future RAFs in a timely basis.

We believe that the terms of the settlement agreement represent a fair and reasonable resolution of this matter. Accordingly, we hereby accept the settlement offer. A.M.A. must comply with these requirements within five business days from the date of issuance of this Order. The contribution will be forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If A.M.A. fails to comply with this Order, its certificate will be canceled administratively. Upon remittance of the \$100 contribution or cancellation of the certificate, this docket shall be closed.
