Based on the information provided, staff has calculated the principle and interest on the overcharges due to QCC, Inc.'s customers. The total refund amount of \$510.43 consists of \$479.55 in overcharges and \$30.88 in interest. This calculation assumes that the overcharges where incurred during February 1999, and that they will be refunded evenly from March 1, 2000 to April 30, 2000. The appropriate interest rate is the average 30-day commercial paper rate for each month. The last available monthly interest rate of 5.43% is used for the future months past November 1999. Attached is a schedule which shows the calculations.
