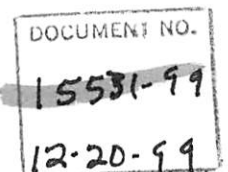

**REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request for Specified Confidential Classification for the response to the Florida Public Service Commission ("Commission's") Data Request issued on November 3, 1999, in the above captioned docket.

1. In a letter dated November 3, 1999, the Commission requested BellSouth to respond to a data request regarding the proposed rule change. The information contained in BellSouth's attachments to the response contain vendor-specific contractual information along with billing and collection costs.

2. The information contained in BellSouth's attachments to the response is proprietary and entails information that is clearly confidential and proprietary under Florida Statutes, Section 364.183.



3. BellSouth has appended to this Request for Confidential Classification as "Attachment A" a list of the location in the response of the information designated by BellSouth as confidential.

4. Appended hereto as "Attachment B" is two copies of the requested documents with the confidential information deleted.
