Docket No. 991699-WS; Application for Amendment of Water Certificate No. 136-W and 97-S to add territory in Pasco County by Aloha Utilities, Inc.

Dear Mr. Deterding:

After reviewing the application in the above referenced docket, the staff has identified the following deficiencies. Please correct and/or provide additional information as requested.

1. As required by Chapter 367.045(2)(b), Florida Statutes, the applicant must provide information on the need or lack of need for service in the area. Although the application indicates there is a need for service, no time frame was provided. Please advise when service will be needed (months or years).
2. As required by Rule 25-30.036(3)(i), Florida Administrative Code, the utility must provide one copy of the official county tax assessment map or other map showing township, range and section, with a scale such as 1"=200' or 1"=400', with the proposed territory plotted thereon by use of metes and bounds or quarter sections, and with a defined reference point of beginning. We were not able to correlate your two page territory description with your one page 8.5 inch by 11 inch map. Please resubmit a map and label all bearings and distances necessary to provide a continuous description.
3. As required by Rule 25-30.036(3)(f), Florida Administrative Code, the utility must provide one copy of a detailed system map showing the proposed lines, treatment facilities, and the territory proposed to be served. The map shall be of sufficient scale and detail to enable correlation with the description of the territory. A copy of the new Riviera Development distribution system and collection system was not attached. Please resubmit.
4. As required by Rule 25-30.036(3)(k), Florida Administrative Code, the utility must provide the numbers and dates of any permits issued for the proposed system by the Department of

Environmental Protection. The water management permit was attached, but the line extension permit from DEP was not attached. Please resubmit.

Please file an original and five copies of the requested information no later than January 31, 2000 with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399. Only one copy of each map is required.
