
**PETITION OF GTE FLORIDA INCORPORATED FOR APPROVAL

**FIRST AMENDMENT TO RESALE AGREEMENT  
BETWEEN  
GTE FLORIDA INCORPORATED  
AND  
1-800-RECONEX, INC.**

**THIS FIRST AMENDMENT** to the Resale Agreement (the "Agreement") which became effective August 11, 1997, is by and between GTE Florida Incorporated and 1-800-RECONEX, Inc. (GTE and Reconex being referred to collectively as the "Parties" and individually as a "Party"). This First Amendment covers services in the state of Florida (the "State").

**WHEREAS**, the Agreement, was approved by the Commission's Order dated November 24, 1997 in Docket No. 97-1030 ("Agreement"); and

**WHEREAS**, the Parties mutually desire to amend the Terms with this amendment to replace existing contractual performance measurements with GTE's nationwide WISE performance measurements.

**NOW, THEREFORE**, in consideration of the mutual promises, provisions and covenants herein contained, the sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Article III, Section 36 of the Agreement first described above shall be deleted in its entirety and replaced by the language set forth in Attachment 1 to First Amendment.
2. Except as specifically modified by this First Amendment, the Agreement shall remain in full force and effect.
3. If any provision in the Agreement conflicts with this First Amendment, this First Amendment shall control.

**IN WITNESS WHEREOF**, each Party has executed this First Amendment and it shall be effective upon execution by both Parties.


