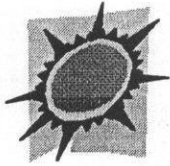

This will acknowledge receipt of your recent request for cancellation of your pay telephone certificate. I cannot recommend voluntary cancellation of a company's certificate when there is an outstanding balance of the regulatory assessment fee and/or statutory penalty and interest charges.

According to the Commission's records, you have a past due balance of \$5.42. Our records show that you paid the 1996 fee on March 6, 1997, which was due January 30, 1997. You paid \$2.37 of the \$5.00 penalty and \$1.50 of the \$1.00 (\$.50 overpayment), for a balance of \$2.13 from 1996. In addition, you paid the 1997 fee on March 2, 1998, which was due January 30, 1998. You paid \$2.75 of the \$5.49 penalty and \$.55 of the \$1.10 interest, leaving a balance of \$3.29.

As soon as your check is received for the \$5.42, I will open a docket to cancel your certificate with an effective date of December 31, 1999. Please let me hear from you by February 8, 2000.
