We have received the above-referenced AFPI filing. However, in order to complete the process, staff needs additional information. Please provide the following information:

- f. Are there any specific rules or regulation by any government agency that advised the utility to place the tank in operation in the present location? If so, explain.
- 4. Provide the following information regarding the tank and distribution lines:
 - a. Were new distribution lines installed to provide water service exclusively to the new customers in the George Mayo Subdivision?
 - b. Are the water distribution mains/lines located in the George Mayo Subdivision interconnected with the existing water lines in Tradewinds Utilities, Inc's. remaining service territory?
- 5. By Order No. PSC-94-0245-FOF-WS, issued March 4, 1994, "the utility purchased an additional 20 acre tract of land for spray irrigation in order to dispose of treated wastewater effluent. The utility recorded the value of this land at \$99,000. However, only 6.6 acres of this land is being used for utility purposes. Of the 6.6 acres, 4.5 acres are for the spray field and 2.1 acres are for the buffer zone. We find it appropriate to adjust the additional land value by (\$66,330) to reflect a value of \$32,670 for the buffer zone and for the land on which the sprayfield is located."
 - a. In the utility's current AFPI proposal, the cost of land was stated at \$162,500 for the water system. In the last rate case for the utility, the Commission established land value at \$99,000 on the wastewater system. Please provide documentation or an explanation why the utility is apparently attempting to change systems to recover on this investment.
 - b. During a conversation between you and Commission staff, the sale of ten acres of land was discussed with a total value of \$162,500. If this is the same land, is it consistent with the above Order that addressed the twenty acres? If so, why was it sold?
 - c. Why were the ten acres repurchased by the utility?
 - d. Provide the utility's calculation on the land valued at \$162,500 for ten acres.
 - e. Provide documentation of the sales transaction that established the sale of land from the utility to the stockholder and from the stockholder back to the utility.
 - f. Explain where the land is located, how the utility acquired it, and why it was acquired.
- 6. Provide a copy of the land appraisal referenced in the utility's Financial Statements submitted to staff for year ending December 31, 1998.
- 7. Does the utility plan to expand the capacity of the water system? Is there remaining service territory available for growth? If so, how much?

8. Does Tradewinds Utilities, Inc. plan to apply for a rate case with the Commission in the near future? If so, when?
