**Re: Docket No. 970409-SU, Initiation of limited proceeding to restructure wastewater rates for Florida Water Service Corporation's Tropical Isles service area in St. Lucie County**

Dear Mr. Concannon:

As promised, I have enclosed a copy of the Chairman's approval of your request for the Tropical Isles agenda item to be heard as early as possible on Tuesday, February 29, 2000. You will notice that our item has been set for a time certain of 11:30 a.m.

I have also enclosed two maps: 1) one is a map of the suggested route to Tallahassee and your motel; and 2) is a map of our office complex. The driving directions to your motel are as follows:

1. Florida Turnpike to I-75.
2. I-75 to I-10.
3. As you near Tallahassee on I-10, the county directly to the east of Tallahassee on I-10 is Jefferson County. Once you enter Jefferson County, take the exit to US 19/Ga Fla Parkway/300.
4. Go south on 19/300 until the junction of US 27.
5. Go west on US 27 until you arrive in Tallahassee. The first major intersection you will go through is the intersection at Capital Circle. Your landmarks at this intersection will be a Shell gas station on your left, with a Chevron gas station on your immediate right and a BP station across the road on the right. (Remember this intersection -- you will turn at this intersection to get to our offices on Tuesday.) Go through this intersection, continuing on US 27 (a/k/a/ Apalachee Parkway) -- the Quinta will be a mile or so down the road on the right.



The driving directions from your motel to the Capital Circle Office Center are as follows:

1. When leaving the La Quinta, turn left and proceed to the Capital Circle intersection.
2. Turn right on Capital Circle. Drive until you reach the third traffic signal -- this places you at the Capital Circle Office Center.
3. Turn left into the complex. You are now on Shumard Oak Blvd. The Gunter Building is down the road on the left (see the green shaded area on the map; also, there is a sign in front of the building). Turn left (this will be the third left once you turn onto Shumard Oak Blvd) -- you will see a large parking area on your left and a smaller parking area on your right (see the purple shaded area on the map). You may park in either lot. My office is in the Gunter Building, room 152-C.
4. The agenda conference will be held in room 148 in the Easley Conference Center (see the pink shaded area on the map). Remember, the Tropical Isles item will begin at 11:30 a.m.

Finally, there are numerous restaurants located on Apalachee Parkway near the La Quinta, so you should not have a problem finding places to eat during your stay here.
