

establishment of compensation methods for the exchange of traffic subject to Section 251 of the Telecommunications Act of 1996 ("Act"). Intermedia exchanges such traffic with incumbent local exchange carriers in Florida according to interconnection agreements under the Act. Thus, the Commission's decisions in this proceeding, which are anticipated to have general applicability, affect Intermedia's substantial interests, entitling Intermedia to participation with party status as a matter of law.


