NOTICE OF PROPOSED AGENCY ACTION
ORDER APPROVING TRANSFER OF CONTROL

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated May 26, 2000, Special Accounts Billing Group, Inc. (SABG) and Orion Technologies, Inc. (Orion) filed with this Commission an application for approval of transfer of control from from Mr. James S. Grabowski, current shareholder of SABG to Orion, through a merger with Globalinx Corporation (Globalinx), a subsidiary of Orion. SABG is the holder of Interexchange Telecommunications Certificate No. 5778. SABG has stated that the transfer of control is in the public interest. SABG further states that the transfer of control will enhance SABG's and Orion's ability to compete in the market for telecommunication services to in Florida and increase their ability to offer more products and services.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of SABG and Orion, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. Our decision does not address the potential impact of the transfer on the competitive market in Florida, or on the companies' or their competitors' interests. We emphasize, however, that our approval of the Petition pursuant to our authority under Section 364.33, Florida Statutes, does not preclude us from addressing any of our concerns that may arise regarding this transaction to the appropriate federal or state agencies.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that Special Accounts Billing Group, Inc. and Orion Technologies, Inc.'s request for approval of transfer of control from Mr. James S. Grabowski, current shareholder of Special Accounts Billing Group, Inc. to Orion Technologies, Inc., through a merger with Globalinx Corporation, is hereby approved. It is further



Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

The action proposed herein is preliminary in nature. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, in the form provided by Rule 28-106.201, Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on August 21, 2000.
