Pursuant to Docket No. 000349-TI, Order No. PSC-00-1037-PAA-TI, ITC^DeltaCom has credited customers for overcharging of 0+ intrastate toll calls placed from pay telephones and in call aggregator contexts between February 1, 1999 and January 18, 2000.

Also, pursuant to the Commission's Order, any amount not refunded, including interest shall be remitted to the Commission and forwarded to the Comptroller for deposit in the General Revenue Fund, pursuant to Chapter 364.285(1), Florida Statutes. The uncredited amounts which ITC^DeltaCom was unable to refund is Ten Dollars and 07/100 (\$10.07). ITC^DeltaCom's check in that amount is enclosed.

Therefore, as required by Rule 25.4.114, Florida Administrative Code, the final report of the matter is as follows:

- a. The amount of money to be refunded: \$429.27;
- b. The amount of money actually refunded: \$419.20;
- c. The amount of any unclaimed refunds: \$10.07;
- d. The status of any unclaimed amounts: A check in the amount of \$10.07 is enclosed with this letter for deposit in the General Revenue Fund; and
- e. The company shall suggest a method for disposing of any unclaimed amounts. ITC^DeltaCom's suggestion would be to add the unclaimed amounts to the universal service fund that is maintained by the State of Florida to keep phone service affordable in rural and other high-cost areas, and to provide discounts for telecommunications services such as Internet access for schools, libraries and rural health facilities.
