I called the company number listed in MCD and spoke with Lill Vader. Ms. Vader said that this company had been located in their offices but they were no longer there. She said her company assumed their telephone numbers. She said she had no forwarding address or phone number and was not sure if they were still in business. She said they have been receiving mail/faxes from the PSC for some time relating to this business.

When I worked in Rick's group, I would send the company (TJ208) a registered letter asking them to contact me. I would reference Rule 25-24.480(2)(a)&(b) {address/phone changes within 10 days} and Rule 25-4.043 {response to Commission inquiries}. Once the register letter was returned to us undeliverable or 30 days past, I would open a Docket and Involuntarily Cancel the company for both of the above violations. They probably have RAF's due as well so Rule 25-4.0161 {RAF non-payment} could also be used to cancel them.

Since this is a compliance issue, I believe the docket would probably be handled by Paula Isler.
