



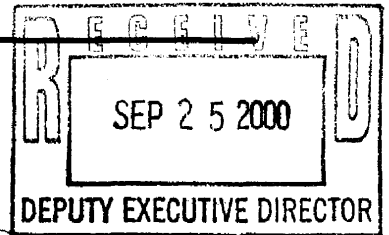

I hereby request a deferment on docket number 001329-TI. Radiant Telecom's intention is to comply with all requirements of the Florida Public Service Commission.

As of this date Radiant Telecom has updated their tariff to include all services that Radiant is now offering and will be offering in the near future. We will be sending in a new revision of our tariff to include a complete list of all charges that will be assessed on our Pre-Paid Calling Cards.

We have sent our amended Regulatory Assessment Fee to include our corrected Florida Gross Operating Revenues. A system has been created to ensure that all tariffs will be kept up to date and all Regulatory Assessment Fees will be paid on time. The Vice-President of Operations and myself have created a committee to update our advertisements and cards to include all fees that will be incurred to customers.

Radiant Telecom will donate \$7,500.00 to the Public Service Commission to defer any costs in which we would have incurred.
