Sprint-Florida, Incorporated will conduct a tour of its Tallahassee-Thomasville Road central office on Wednesday, October 25, 2000, at 10:00 a.m., EST, as required in the above-referenced docket. Parties and interested persons are asked to send no more than two representatives to the tour. The central office is in Tallahassee, Florida, at **5000 Thomasville Road**. Directions are below and are from Tallahassee Airport.

Turn left on Capital Circle from the airport and drive to the light where Capital Circle deadends. Turn left at the light (you will be on the continuation of Capital Circle)

Drive on Capital Circle until you get to the I-10 interchange (go past SR20 (Pensacola Street), US90 (Tennessee Street), and Tharpe Street.

Take I-10 east to exit 30 (Thomasville Road). Make a left onto Thomasville Road and go north approximately 3 miles. The driveway to the Thomasville Road CO will be on your right just past the Foxcroft subdivision (Ox Bottom Road will be almost directly across on your left). There is a mailbox with "Sprint" on it at the entrance to the driveway. If as you drive you come to Kerry Forest Parkway, you've passed it.

If you are driving in on I-10, just use the directions from Exit 30.
