Re: Broadview Park Water Company

Dear Mr. Donner:

This letter is in reference to our telephone conversation of November 14, 2000, during which we discussed the delinquency of Broadview Park Water Company (Broadview Park or utility) in paying its water bill to the City of Ft. Lauderdale (City).


As you know, Broadview Park's continued payment delinquency is a serious matter which places the utility's customers in jeopardy of service interruption. Pursuant to Section 367.111, Florida Statutes, the utility is required to provide continuous service to the area described in its certificate of authorization. If the utility fails to provide such service, the Public Service Commission (Commission) may initiate proceedings to rescind Broadview Park's certificate of authorization.

You have indicated that you will put forth your best efforts to resolve this problem. By this letter, we are requesting that you submit, within two weeks of your receipt of this letter, a plan delineating the actions the utility will take to pay the delinquent bill to the City. If the utility has agreed upon a payment plan with the City, we are requesting that you attach a copy of such plan with your letter.

Enclosed is a copy of the Class B minimum filing requirements form used for filing a rate case. If the utility believes that a rate case or limited proceeding is necessary, it will need to comply with the rules governing the filing for rate relief. Staff is available to address any questions you may have regarding the applicable rules for filing for such rate relief.
