CALPINE'S NOTICE OF VOLUNTARY DISMISSAL OF ITS PETITION
FOR DETERMINATION OF NEED AND REQUEST TO CLOSE DOCKET

Calpine Construction Finance Company, L.P., ("Calpine"), hereby gives notice of the voluntary dismissal, without prejudice, of its Petition for Determination of Need for the Osprey Energy Center ("Osprey Project") which Calpine filed with the Commission on June 19, 2000. Calpine and Seminole Electric Cooperative, Inc., ("Seminole") will file a Joint Petition for Determination of Need for the Osprey Project on or before December 1, 2000. The Joint Petition will address Seminole's need for additional generating capacity and energy and reflect the contractual arrangement between Seminole and Calpine pursuant to which the Osprey Project will meet Seminole's need.

Calpine requests that the Commission close Docket No. 000442-EI, which was opened by Commission Staff on April 14, 2000. Calpine respectfully suggests that this voluntary withdrawal and request to close Docket No. 000442-EI renders all

pending motions in Docket No. 000442-EI moot. Accordingly, Calpine requests that the Commission refrain from issuing any orders concerning pending motions in Docket No. 000442-EI.
