This will acknowledge receipt of your recent request for cancellation of your pay telephone certificate. I cannot recommend voluntary cancellation of a company's certificate when there is an outstanding balance of the regulatory assessment fee and/or statutory penalty and interest charges.

According to the Commission's records, you have a past due balance of \$30.50. Our records show that you paid the 1996 fee on June 30, 1997, which was due January 30, 1997. However, you did not pay the \$12.50 penalty or \$3.00 interest, leaving a balance of \$15.50 for 1996. You paid the 1997 fee on April 16, 1998, which was due January 30, 1998. However, you did not pay the \$7.50 penalty and \$1.50 interest leaving a balance of \$9.00 for 1997. You paid the 1998 fee on March 10, 1999, which was due February 1, 1999. However, you did not pay the \$5.00 penalty or \$1.00 interest, leaving a balance of \$6.00 for 1998.

As soon as your check is received for the \$30.50, I will open a docket to cancel your certificate with an effective date of December 31, 1999. Please let me hear from you by February 8, 2000.
