The purpose of this letter is to advise the Florida Public Service Commission that Smart City Telecommunications L.L.C. ("Smart City") intends to operate in Florida under the fictitious name "Smart City Telecom." Subject to the closing of the sales agreement between Smart City and Vista-United Telecommunications, which is anticipated to occur sometime in the first quarter of 2001, Smart City will be the owner and holder of the Certificates of Public Convenience and Necessity Nos. 1971 (LEC) and 2442 (IXC). The transfer of these certificates is addressed in FPSC Order No. PSC-00-2230-PAA-TP, issued November 22, 2000.

Smart City Telecommunications L.L.C. is also the holder of PATS certificate No. 7664. See Order No. PSC-00-2234-PAA-TC issued November 27, 2000.

Smart City requests that its LEC, IXC and PATS certificates be updated to reflect its intent to operate under a fictitious name. A copy of the acknowledgment letter from the Florida Department of State received by Smart City Telecommunications L.L.C. is attached hereto as Exhibit A. A copy of the fictitious name registration for Smart City Telecom on the Department of State's web site is attached hereto as Exhibit B.




