Dear Mr. Pikoff:

As we discussed on January 18, the above docket was established for nonpayment of the 1999 Regulatory Assessment Fee (RAF), plus statutory penalty and interest charges. You advised me that DPI wished to keep its certificate active and would pay the past due balance and propose a settlement. The 1999 fee, including penalty and interest charges, has been paid. In addition, the Commission has received two settlement proposals from two different sources. Both are discussed below.

#### **Telecom Compliance Services (TCS)**

On January 24, the Commission received a letter dated January 16, 2001, from Ms. Kelli L. Muhammad, TCS, on behalf of DPI. Ms. Muhammad stated that steps had been taken to prevent this from happening in the future and offered a settlement of \$100 to resolve this docket. On January 25, I advised Ms. Muhammad that I could not recommend acceptance of a \$100 settlement since this is the second time a docket had been established for the same rule violation and explained that a waiver of objection statement needed to be included in the settlement. On January 29, the Commission received Ms. Muhammad's amended settlement proposal dated January 26, increasing the settlement amount to \$500 and including the waiver of objection statement.

I can now recommend acceptance of the proposal since all elements have been included and the \$500 settlement proposal is consistent with prior Commission decisions.

#### Tax Partners, LLC

Mr. Ken Hoekstra wrote the Commission a letter dated January 25, 2001. Mr. Hoekstra stated that steps had been taken to prevent this from happening in the future and asked that the fine be waived or reduced due to the numerous steps to correct the problems.

I cannot recommend acceptance of Mr. Hoekstra's settlement proposal. The Commission's Division of Legal Services has recently advised me that if a Proposed Agency Action Order has not been previously issued in a docket, a company's settlement proposal must include a waiver of objection to the administrative cancellation of the certificate in the event the company's offer is accepted and then fails to comply with the terms which it has offered.

This is the second docket established for the same rule violation. The first docket was No. 990672-TX, which was established for nonpayment of the 1998 RAF. In that docket, the Commission imposed a \$500 fine. You responded on behalf of DPI to the Commission's Order by paying the past due amount and proposing a settlement. In that proposal, you stated that "measures are in place so as never to let this oversight happen in the filing of our annual Regulatory Assessment Fees again." The Commission accepted the company's settlement offer and DPI paid the \$100 settlement amount and the docket was then closed.

When two dockets have been established for the same rule violation, there is normally a \$1,000 fine imposed by the Commission. This means that in order for me to recommend acceptance of Tax Partners' offer, Mr. Hoekstra would need to amend his settlement proposal to include the waiver of objection statement and a specific monetary amount consistent with prior Commission decisions. The alternative is that if the proposal was not amended, I would write a recommendation to deny the proposal and impose a \$1,000 fine.

This is our settlement letter in regards to the above docket number on behalf of DPI Teleconnect. For the 2000 Florida Regulatory Assessment Fee, we had inadvertently neglected to include the \$50 minimum fee. Paula Isler from the Bureau of Service Evaluation & Compliance had called us in October to inform us of this oversight. Unfortunately, we had changed our phone extensions the same time Paula had called. Thus, we did not return her call nor did we receive any future calls because of the changed phone extensions even though Paula did try a few more times. On January 18, 2001, Paula called DPI Teleconnect explaining the situation. Immediately following, DPI Teleconnect contacted me directly. The same day, I contacted Paula Isler to remedy the situation with the 2000 Fee that was past due. I explained what happened to Paula and apologized to her that we did not return her phone calls. At this time, I also provided Paula with my direct phone number and email address if she had any further issues or questions. The same day, I overnighted the check due to Florida for the \$50 plus penalties and interest. I also explained that this oversight will not happen again. Steps taken to prevent this from happening again include better voicemail capabilities if phone extensions change and a meeting with all of our tax analysts on the proper procedures for handling the Regulatory Assessment Fee Return.

I would like to ask that the Florida Public Service Commission look upon DPI Teleconnect in a favorable way. As we handle DPI's tax filings, this was our mistake. We respectfully ask that the fine imposed for this violation be waived or reduced as we have taken numerous steps to correct the above problems. We will respect whatever decision is made by the Commission.

I would like to thank Paula Isler for her assistance in clearing up this matter. Paula was extremely helpful and courteous over the phone. I would also like to thank you for your time in reading this letter.
