CASE BACKGROUND

On May 24, 2000, Sprint Communications Company Limited (Sprint) filed complaint against BellSouth Partnership а Telecommunications, Inc. (BellSouth) for alleged failure to comply with the provisions of the BellSouth/Sprint interconnection agreement. The Commission held a formal hearing on November 9, During the hearing, the Commission approved the parties' 2000. agreement to insert all testimony and exhibits into the record and to waive cross examination. On November 30, 2000, the parties filed post-hearing briefs. On February 2, 2001, however, Sprint filed a Notice of Voluntary Dismissal, indicating that it withdraws and voluntarily dismisses, with prejudice, its complaint against This recommendation addresses Sprint's notice. BellSouth. The Commission is vested with jurisdiction over this matter pursuant to Sections 251 and 252 of the Telecommunications Act of 1996.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission acknowledge Sprint Communications Company Limited Partnership's Notice of Voluntary Dismissal of its complaint against BellSouth Telecommunications, Inc.?

STAFF ANALYSIS: Sprint filed a complaint against BellSouth which it has withdrawn and voluntarily dismissed with prejudice. Therefore, staff recommends that the Commission acknowledge Sprint's Notice of Voluntary Dismissal.
