JOINT REQUEST FOR CLARIFICATION OF ISSUE A

BellSouth Telecommunications, Inc. ("BellSouth") and Supra Telecommunications and Information Systems, Inc. ("Supra"), hereby file this joint request for clarification of Issue A.

At the beginning of this arbitration, the parties asked this Commission to resolve approximately sixty-six issues identified in BellSouth's Petition for Arbitration and Supra's Response to that petition. In addition, the Commission identified an additional issue – Issue A – to resolve Supra's claims that BellSouth acted in bad faith. Among the claims that Supra made was its claim that BellSouth acted in bad faith when it refused to agree to use the parties' existing agreement as the basis for negotiating the Follow-On Agreement. The description of Issue A in the Draft Pre-Hearing Order, however, limits Issue A to:

Has BellSouth or Supra violated the requirement to Commission Order PSC-01-1180-FOF-TI to negotiate in good faith pursuant to Section 252(b)(5) of the Act? If so, should BellSouth or Supra be fined \$25,000 for each violation of Commission Order PSC-01-1180-FOF-TI, for each day of the period May 29, 2001 through June 6, 2001?

The parties disagree over which agreement template will be used as the base agreement into which the Commission's decisions on the disputed issues will be incorporated. The parties agree that, in addition to resolving the disputed issues, the Commission must also decide which base agreement will be used. Because the scope of Issue A does not expressly include this issue, the Commission should direct the parties to include in their post-hearing briefs a discussion of this issue. It is the parties' expectation that the Commission will decide this issue when it issues a final order in this docket. The parties believe it is important for the Commission to decide this question because, without an order from the Commission on this point, the parties will be unable to submit a final agreement for approval in accordance with 47 U.S.C. § 252.
