

1. On October 19, 2001, BellSouth provided the Commission with the required information regarding BellSouth's request for additional numbering resources in the Miami exchange, in compliance with Order No. PSC-01-1973-PCO-TL ("Order"). BellSouth filed this information along with a Notice of Intent to Request Specified Confidential Classification.

2. Pursuant to Rule 25-22.06(3)(a), BellSouth is now filing a Request for Confidential Classification for the subject information because the information contained in BellSouth's response to the Order contains confidential and proprietary business information that is considered confidential and proprietary to BellSouth. A more specific description of this information is contained in Attachment A.

3. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.


4. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.


