We received today a new filing for approval of interim traffic termination and billing agreement, with XO Florida, Inc. It appears to be similar to the the agreement Vista-United filed with Adelphia Business Solutions on 2/28, which was assigned Docket 010269-TP.

Our concern then, and now, is that Vista-United Telecommunications no longer has a LEC certificate. The cert was transferred and name changed to "Smart City." How can a non-cert'd company file for approval of an agreement?

We will go ahead and docket today's filing, just as we did the one on the 28th, but I wanted to be sure you were aware of the situation so whatever action is appropriate can be taken.
