**PROTEST/OFFER OF SETTLEMENT OF PROPOSED AGENCY ACTION**

COMES NOW, Eureka Telecom, L.L.C. ("Eureka") through its undersigned counsel and submits the Protest to the Proposed Agency Action or in the alternative, an Offer of Settlement and as basis would show:


1. Eureka Telecom, L.L.C. holds Certificate No. 7654, authorizing the provision of interexchange services within the state of Florida. On October 21, 2002, the Commission issued its Notice of Proposed Agency Action Order ("PAA") No. PSC-02-1443-PAA-TI expressing its intent to impose a penalty on Eureka, and several other carriers, for failing to pay the Regulatory Assessment Fee ("RAF") for 2001.

2. As permitted by Rule 25-22.029 and Order No. PSC-02-1443-PAA, Eureka would request a hearing on the PAA and the action proposed to be taken by the Commission. Alternatively, Eureka offers to pay the outstanding RAF for 2001 plus penalty and interest and a fine of \$100.00 to be paid to the PSC for deposit in the General Revenue Fund. The RAF and return form are being submitted to the PSC with this Protest/Offer of Settlement and the fine, if accepted, will be forwarded within 14 days of acceptance of the amount.

3. Eureka did not receive any revenue from IXC customers during 2001 and does not now have any intrastate revenues. However, Eureka wants to keep its certificate active and submits this Protest/Offer of Settlement as an equitable resolution of the PAA. Eureka has also reviewed its internal procedures and implemented revisions to insure that responses and filings are timely in the future.

4. Eureka requests that the Commission act favorably on this offer and accept it.
