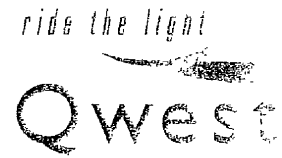

Enclosed please find an original and four (4) copies of a transmittal letter to withdraw USLD Communications, Inc.'s ("USLD") Florida Price List No. 1 (Local Exchange Service) in its entirety.

USLD is proposing to withdraw its Local Exchange Service, including Local Payphone Access Lines ("PAL"). USLD currently does not have any residential or business Local Exchange Service or PAL customers in Florida. Therefore, USLD can no longer justify the maintenance costs associated with the lack of traffic volume.

USLD does offer local Operator Assisted Services and the rates associated with this service can be found in USLD Communications, Inc.'s Tariff Fla. P.S.C. No. 1 (Direct Dialed and Operator Assisted Resale Telecommunications Services). This filing does not impact those rates.

USLD respectfully requests that this withdrawal become effective on November 5, 2002.
