On January 5, 2001, IDS Telecom, LLC (IDS) filed a petition for arbitration of terms and conditions of interconnection agreement with BellSouth Telecommunications, Inc. (BellSouth) pursuant to Section 252(b) of the Telecommunications Act of 1996. By letter dated July 16, 2001, IDS requested to withdraw its petition for arbitration in its entirety because all issues had been resolved.

The parties filed a final executed interconnection agreement on July 11, 2001, which has gone into effect by operation of law in accordance with Section 252(e)(4) of the Telecommunications Act of 1996. Since the Commission does not need to take any further action in this matter, this docket may remain closed.
