As we discussed yesterday, I've been unable to locate the filing made by Verizon f/k/a GTE for TCG South Florida to adopt the AT&T/GTE agreement (960847-TP).

The amendment reflected in the subject line above includes a letter from GTE to TCG dated February 20, 1998 and is signed by both companies agreeing to certain points. In a subsequent letter dated March 6, 1998 from Beverly Menard to FPSC staff, a docket file was not going to be opened for this adoption, but she was attaching a copy of the agreement. Both of these letters are in the current docket file.

While a docket was not opened, at the time this adoption took place, agreements were logged into our Tariff Filing Information System (TFIS) as a way to track them. This was not done in the case of this adoption, and staff cannot locate the agreement referenced in the March 6, 1998 letter.

Nevertheless, staff believes the February 20, 1998 letter, signed by both companies constitutes an adoption of Docket No. 960847-TP. For the sake of efficiency, staff is planning to administratively process the amendment using normal procedures, without any further action necessary on the adoption.
