Issued January _____, 2005

On October 1, 2004 Aloha Utilities, Inc. applied to the Florida Public Service Commission for authorization to implement a new class of water service for private fire protection. The staff of the Florida Public Service Commission undertook an investigation and review of the proposal for a new class of service and new rates and by Order No. PSC-04-1257-TRF-WU issued on December 20, 2004 the Florida Public Service Commission approved the new class of service and the tariff as filed. That Order has now become final.

In order to qualify for this new service, the customer will be responsible for constructing, reconfiguring, and maintenance of the onsite system and providing the appropriate plans and engineering specs to ensure Aloha the complete separation of the fire flow and domestic services. The customer will also be responsible for providing meters and interconnections to the Utility's systems in accordance with the Utility's standard Service Availability Policy, in order to accommodate the provision of the new class of service.

The new rates for private fire protection have now been implemented for all persons receiving such service. Those rates are outlined below:
