



IN LEE COUNTY BY
GISTRO, INC.

Notice is hereby given on July 20, 2005 pursuant to Section 367.045, Florida Statutes, by Gistro, Inc., P.O. Box 110131, Naples, Florida 34108, of its application to the Florida Public Service Commission for an initial certificate of authorization for a wastewater certificate and initial rates and charges, for the following territory located in Lee County, Florida: The North 1/2 of the SE 1/4 of Section 25, Township 47 South, Range 25 East, less and except the following parcel: Commencing at the East 1/4 corner, also the Point of Beginning, thence run a distance of 540 feet due West, thence run South 9 degrees East a distance of 1350 feet, thence run 300 feet due East to the East line of said Section, thence run due North a distance of 1280 feet to the Point of Beginning.
