

**PETITION FOR APPROVAL OF
FLORIDA PUBLIC UTILITIES COMPANY'S
CONSERVATION COST RECOVERY FACTORS**

Florida Public Utilities Company ("the Company"), through its undersigned attorneys and pursuant to the requirements of this docket, hereby petitions the Commission for approval of the Company's conservation cost recovery factors on a consolidated basis for each of its two electric divisions for the period January, 2006 through December, 2006. In support hereof, the Company states:

- 3) Pursuant to the requirements of this Docket, the Company has prefiled the conservation cost recovery forms supplied by the Electric & Gas Department in a manner consistent with the Department's instructions.

4) As indicated in the prefiled forms, the consolidated recoverable conservation costs for the period January, 2006 through December, 2006 is projected to be an overrecovery of \$495,200. The consolidated conservation cost recovery true-up amount for the period January, 2005 through December, 2005 is an overrecovery of \$113,942.

5) The resulting net total projected conservation costs on a consolidated basis to be refunded for the period January, 2006 through December, 2006 is an overrecovery \$381,258. Based upon projected sales the appropriate consolidated levelized conservation cost recovery factor for the period January, 2006 through December, 2006 is \$.00047.

WHEREFORE, Florida Public Utilities Company petitions the Commission to approve the foregoing conservation cost recovery factors on consolidated basis, to be applied to customer bills for the period January, 2006 through December, 2006, and to billings thereafter until other conservation cost recovery factors are approved by the Commission.
