Although Citrus County took back jurisdiction over water and wastewater utilities several years ago, our County Code states that we will look to the FPSC rules and regulations where our code is silent. Therefore, this docket may have an impact on us even without the FPSC having direct jurisdiction. At this point in time, we wish merely to be an Interested Party rather than file for the right to intervene, which we reserve to do if we so desire in the future.
