**CHAPTER 13 PLAN**

The projected disposal income of the debtor is submitted to the supervision and control of the trustee. The debtor shall pay the trustee by money order or cashier's check following the filing of this Chapter 13 Plan and the entry of a pre-confirmation order the sum of \$107.00 to a maximum of 60 months. Upon confirmation of the plan, the trustee shall make distributions on allowed claims as follows:

**PRIORITY PAID IN PLAN:** The trustee's percentage fee set by the U.S. Trustee.

**ATTORNEYS FEES FOR DEBTOR'S COUNSEL PAID IN PLAN:** 1,600.00  
From the payments received from the Debtor, the trustee will pay additional fees to Debtor's counsel of at least \$1,600.00 without a fee application, or additional fees based on a fee application. Any objection to such additional fees must be filed as an objection to confirmation under the terms and time limits described in the notice of the confirmation hearing.
