Pursuant to this Court's Initial Scheduling Order of September 7, 2006, Plaintiff Florida

Digital Network, Inc. ("FDN"), Defendant Sprint-Florida, Inc. n/k/a Embarq Florida, Inc.

("Embarq"), and Defendant Florida Public Service Commission and its Commissioners named in

their official capacities, Lisa Polak Edgar, J. Terry Deason, Isilio Arriaga, Matthew M. Carter, III

and Katrina J. Tew (collectively, "FPSC" or "Commission"), by and through undersigned

counsel, hereby submit this Joint Report of the Parties.

1. Conference of the parties. Pursuant to the Federal Rule of Civil Procedure

26(f), the parties met and conferred on October 4, 2006. The meeting occurred via

teleconference and was attended by the following: David Smith, counsel for the Commission; Jeff Wahlen, counsel for Embarq; Michael Sloan, counsel for FDN.

2. Nature and Basis of Claims and Defenses. FDN filed this action, pursuant to 28 U.S.C. § 1331 and 47 U.S.C. § 252(e)(6), to challenge certain decisions of the Commission setting the rates at which FDN is permitted to lease various components of Embarq's network pursuant to the interconnection agreement between the parties. FDN alleges that the Commission's refusal to permit FDN to arbitrate new rates in the proceeding before the Commission was inconsistent with the requirements of §§ 251 and 252 of the Communications Act and the implementing regulations issued by the Federal Communications Commission ("FCC").

Embarq and the FPSC deny FDN's allegations. This case is an appeal of orders issued by the FPSC in Docket No. 041464-TP, an arbitration between FDN and Embarq. Embarq asserts that its prices for unbundled network elements were set in FPSC Order No. PSC-03-0058-FOF-TP, Dkt No. 990649B-TP (Jan. 8, 2003), which order was affirmed by this Court and the Eleventh Circuit in appeals by FDN in <u>Florida Digital Network, Inc. v. Embarq Florida, Inc.</u> (<u>11th Cir.</u> Case No. 05-16653-HH and ND Fla. Case No. 4:03cv-00282-RH/WCS) and that the decisions of the FPSC in Docket No. 041464-TP comport with the requirements of §§ 251 and 252 of the Act and the implementing regulations issued by the Federal Communications Commission ("FCC").

3. **Rule 26(a)(1) and (a)(2) Disclosures**. Local Rule 26.1 exempts the parties from the disclosure requirements of Federal Rules of Civil Procedure 26(a)(1) and (a)(2) in actions "seeking review, upon a fully developed record, of administrative determinations of

governmental departments or agencies." N.D. Fla. Local Rule 26.1(c); see also Fed. R. Civ. P.26(a)(1)(E)(i) (exempting "action[s] for review on an administrative record" from the initial disclosure requirements of Federal Rule of Civil Procedure 26(a)(1)). This case is in the nature of an administrative appeal, on a closed factual record developed before the Commission. Thus, the parties are exempt from the requirements of Federal Rules of Civil Procedure 26(a)(1) and (a)(2) and do not intend to submit such disclosures.

4. **Discovery Plan**. Likewise, because this case is in the nature of an administrative appeal on a closed record already developed before the PSC, discovery and trial are neither necessary nor warranted. *See generally* Fed. R. Civ. P.26(a)(1)(E)(i); N.D. Fla. Local Rule 26.1(c). No party intends to request any interrogatories, requests for admissions, depositions, expert reports or any other discovery, and no trial will be necessary. Review will be limited to the record developed before the PSC and to the arguments of counsel through appellate-style briefing and oral argument. This is the same procedure that is being or has been followed in prior cases brought in this Court pursuant to 47 U.S.C. § 252(e)(6)

5. Possibility of Settlement and/or Success of Mediation.

The parties do not believe that settlement and/or mediation is a realistic approach to resolving this case.

6. Magistrate Supervision.

Pursuant to Local Rule 73.1(A), the parties have conferred on the matter of magistrate judge jurisdiction.
