The Schedules behind Tab A (E-14(a)) are related to the Company's historic flat rate billing structure for residential, multi-family, and lift station customers. Commercial customers use a base facility/gallonage charge rate structure. This information is shown for the historic period

The Schedules behind Tab B (E-14(b)) is based on the water customer and usage data received from the Florida Keys Aqueduct Authority (FKAA) for the year ended December 31, 2006. Also included are those customers who have connected or have agreed to connect during 2007. This data is the basis for the proposed rate calculations. By agreement or by their unique circumstances, certain customers will remain flat rate, such as the Pool Houses, which would require separate sub-metering as they are connected to the irrigation systems, and the marinas, which water flows are used predominately at boat slips for boat washing.
