- 5) The estimated true-up amounts for the period January 2007 through December 2007 are an underrecovery of \$764,661 for the Marianna Division and an underrecovery of \$1,188,605 for the Fernandina Beach Division.
- As indicated in the prefiled true-up forms, the total true-up amounts to be collected or refunded during the January 2008 through December 2008 period are underrecovery of \$690,530 for the Marianna Division and an underrecovery of \$915,677 for the Fernandina Beach Division.
