**PETITION FOR APPROVAL OF FLORIDA PUBLIC UTILITIES COMPANY'S FUEL
ADJUSTMENT AND PURCHASED POWER
COST RECOVERY TRUE-UP AMOUNT**

Florida Public Utilities Company ("FPUC"), by and through its undersigned counsel, submits this Petition for approval of FPUC's fuel adjustment and purchased power cost recovery estimated true-up amount for the period January 2007 through December 2007. In support hereof, the Company states:

1) The Company is an electric utility within the jurisdiction of this Commission. Its principal business address is:

3) Pursuant to the requirements of this Docket, the Company has prefiled the fuel adjustment and purchased power cost recovery true-up forms supplied by the Commission Staff in a manner consistent with the Commission Staff's instructions.

4) The final remaining true-up amounts for the period January 2006 through December

2006 are an overrecovery of \$74,131 for the Marianna Division and an overrecovery of \$272,928 for the Fernandina Beach Division.

5) The estimated true-up amounts for the period January 2007 through December 2007 are an underrecovery of \$764,661 for the Marianna Division and an underrecovery of \$1,188,605 for the Fernandina Beach Division.

6) As indicated in the prefiled true-up forms, the total true-up amounts to be collected or refunded during the January 2008 through December 2008 period are underrecovery of \$690,530 for the Marianna Division and an underrecovery of \$915,677 for the Fernandina Beach Division.

WHEREFORE, the Company respectfully requests that this Commission enter its order approving the Company's true-up amount for the period January 2006 through December 2006.
