#### NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Progress Energy Florida, Inc., ("PEF" or "Company"), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request Confidential Classification of confidential portions of PEF's negotiated purchase power contract ("the Contract") with BG&E of Florida, LLC ("BG&E") dated July 25, 2007.

Specifically, portions of the Contract contain sensitive business information concerning contract pricing and terms, the disclosure of which would impair the efforts of the Company to negotiate purchase power contracts on favorable terms. If contract companies CMP were allowed to compare the rates and terms being negotiated, it could lead to adverse effects COM for both PEF and BG&E, causing an increase in negotiated purchase power contract rates.
