SECOND ORDER REVISING ORDER ESTABLISHING PROCEDURE AND GRANTING AQUA UTILITIES FLORIDA, INC.'S UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE REBUTTAL TESTIMONY TO CONCERNS RAISED AT CUSTOMER SERVICE HEARINGS

On August 10, 2007, Aqua Utilities Florida, Inc. (AUF or utility) filed its Unopposed Motion for Extension of Time to File Rebuttal Testimony to Concerns Raised at Customer Service Hearings and Request for Expedited Ruling (Motion). In it, AUF states that it is currently engaged in a number of significant tasks in this proceeding, including addressing and responding to customer complaints raised at customer service hearings, responding to ongoing discovery requests, reviewing and analyzing the prefiled testimony and exhibits recently filed by the Office of Public Counsel (OPC), and preparation for requested oral argument on the Joint Motion to Dismiss filed by OPC and the Attorney General, State of Florida (AG). AUF requests an additional 7 days in which to file its rebuttal testimony and exhibits addressing concerns raised at the customer service hearings.

Being fully advised on the premises and noting the Motion is unopposed by OPC and the AG, I find it appropriate to grant the Motion. Order No. PSC-07-0219-PCO-WS, issued March 9, 2007, Establishing Procedure in this docket, and Order No. PSC-07-0540-PCO-WS, issued June 28, 2007, First Order Revising Order Establishing Procedure in this docket, are hereby revised to reflect that AUF shall file its rebuttal testimony and exhibits addressing concerns raised at the customer service hearings by August 28, 2007.

It is, therefore

ORDERED by Commissioner Matthew M. Carter II, as Prehearing Officer, that Order Nos. PSC-07-0219-PCO-WS, Establishing Procedure, and PSC-07-0540-PCO-WS, First Order Revising Order Establishing Procedure, are hereby revised as set forth in the body of this Order. It is further

ORDERED that Aqua Utilities, Inc.'s Unopposed Motion for Extension of Time to File Rebuttal Testimony to Concerns Raised at Customer Service Hearings and Request for Expedited Ruling is granted. AUF shall file its rebuttal testimony and exhibits addressing concerns raised at the customer service hearings by August 28, 2007. It is further

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Office of Commission Clerk, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
