AT&T FLORIDA'S REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, files its Request for Specified Confidential Classification.

- 1. On July 30, AT&T Florida filed its Notice of Filing Additional Documents in Support of its Petition in the captioned docket. Exhibit Nos. 1, 2 and 3 contain information considered to be confidential business information. A Notice of Intent to Request Specified Confidential Classification was also filed on the same day.
- 2. Pursuant to Rule 25-22.006, AT&T Florida hereby files this Request for Specified Confidential Classification because the above documents contain information considered confidential business information related to the competitive interests of AT&T Florida that is proprietary to AT&T Florida. A more specific description of this information is contained in Attachment A.
- 3. Public disclosure of this information would cause competitive harm to AT&T Florida and provide competitors with an unfair advantage. The information discussed in this Request for Specified Confidential Classification is valuable and AT&T Florida strives to keep it secret. Therefore, such information should be classified as confidential business information pursuant to Section

364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

- 4. Attachment A to AT&T Florida's Request for Confidential

 Classification contains an explanation of the proprietary information along with a list that identifies the location of the information designated by AT&T Florida as confidential.
- 5. Attachment B to AT&T Florida's Request for Confidential Classification is redacted copies of the document containing the confidential information.
- 6. Attachment C to AT&T Florida's Request for Confidential Classification is a highlighted copy of the document containing the confidential information.
- 7. The original of this Request was filed today with the Office of the Commission Clerk and a copy was served on the Parties.

WHEREFORE, based on the foregoing, AT&T Florida respectfully requests that, pursuant to Section 364.183, Florida Statutes, the Commission enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure.

Explanation of Proprietary Information
