Dear Ms. Johnson:

Pursuant to our conversations, regarding the above styled, I am providing the following information, in order to resolve this matter.

On December 29, 2005, Mr. Frank Uddo and his wife Dolores, sold approximately 275 acres of land to FMC Development, LLC., to develop a residential community. At the time of the sale, a section of the land was withheld from the sale property for the purpose of providing a utility service to the new development. This particular section of land remained in Frank and Dolores Uddo's name. Because Mr. Uddo had previously qualified and owned and operated a utility, St. Johns Landing of Putnam County Utilities Services, Inc., it was his plan to provide the utilities services, to the new owners until they were qualified to purchase and operate the utility. This was the purpose of the application to transfer the utility certificates, filed on or about the 26th of September, 2006.

Since the filing of the application for transfer, the said property sold to FMC Development, LLC has gone into foreclosure. We are currently awaiting a certified copy of the service of process from the Secretary of State.

Upon the completion of the foreclosure, all the property will once again belong to Mr. Uddo and his wife and will again be listed for sale.




