

NOTICE TO CUSTOMERS

Pursuant to Section 367.081 (4) [a] [b], Florida Statutes, water and wastewater utilities are permitted to pass-through, without a public hearing, a change in rates resulting from: an increase or decrease in rates charged for utility services received from a governmental agency or another regulated utility and which services were redistributed by the utility to its customers; an increase or decrease in the rates that it is charged for electric power, the amount of ad valorem taxes assessed against its used and useful property, the fees charged by the Department of Environmental Protection in connection with the National Pollutant Discharge Elimination System Program, or the regulatory assessment fees imposed upon it by the Commission; and costs incurred for water quality or wastewater quality testing required by the Department of Environmental Protection.

On March 26, 2007 Labrador Utilities, Inc. filed its notice of intention with the Florida Public Service Commission to increase sewer rates in Pinellas County pursuant to this Statute. The filing is subject to review by the Commission Staff for accuracy and completeness. If approved by the Commission, water & sewer rates would be increased by 1.07% and 1.90%, respectively, coinciding with a \$0.03 increase in usage rates for water customers and \$0.18 increase in usage rates for wastewater residential customers and \$0.21 increase in usage rates for wastewater general service customers. These rates should be reflected on your bills for service rendered on or after May 26, 2007.

This is a follow-up to the meeting that was held by the Public Service Commission in Forest Lake Estates on November 2, 2006.

On October 31-06 we arrived back in Forest Lake Estates and turned on our water.

We did notice that a new meter had been put in. The water came on as planned.

The following morning we got up to the meter leaking. It was filling the meter box. A call was placed to Labrador Utilities on November 1 and we were told that there had been a lot of problems and the man was very busy and he would get to us either that day or the next.

On November 2nd we went to the meeting with the Public Service Commission and upon returning home, we found that the water was now flowing down the street from our meter. (Dated Pictures are enclosed)

On November 3, Labrador was called again. (See enclosed Vonage Phone Print out) Calls are circled.

We were told at the point that the man had been here but didn't have the parts and would have to order them and it probably wouldn't be until Monday. Once again, Monday came and went and still no fix. The service man came on November 7 and fixed the problem. I have been coming to this state for a number of years and have lived in South West Florida and know that water is scarce. Since Nov 1 Labrador allowed the water to run down our street 24 hours a day until November 7/07.

When I was speaking to a girl (Debbie) we discussed the new meters and I asked the question why didn't they turn on the water to test them at the time of installation? She said that is what they should have done. She also told me not to call unless I had an emergency because I wasn't paying for the water that was running down the street, it was the responsibility of the Utility Company. It may be the responsibility of the Utility but we as customers are paying for it in the long run. And waste is not an option.....

Well, it cost money for them to treat and purify that water (Even if you can't drink it) and that is total neglect on their behalf. I am also enclosing pictures that are dated of most of the days that the water ran down the street.

If the Public Service Grants an increase to Labrador with all the problems that this park is having, you are only rewarding them for bad behavior and poor business practices.

People shouldn't have to buy water purifiers and filter systems when they pay dearly for water that is suppose to already be purified. I'm sure that you saw the filter that came off a home that day at the meeting. I'm also sure that you or your family would not want to have that kind of water running through your pipes. Stop and think about that. People are coming in here buying homes and probably none of them have ever asked about the water. We didn't and we are only here 3 years. Would you like to live here?

It is time that the Public Service Commission told Labrador that there is a cost of doing business and until they clean up their act and become a good corporate citizen there will be no more increases.

This email is regarding PSC Docket No. 060262-WS, the price increase for Labrador Utilities in Forest Lake Estates. We have steadily seen our water and sewer bill go significantly higher year by year but see no improvements to our drinking water or sewer. We have to buy bottled water for drinking, cooking and making coffee because the odor of the water is offensive and if you let your glass sit, it has sediment in it. I live about 5 houses down from the sewer treatment plant and the odor that comes out of there is obnoxious. We bike ride around the park daily and some days you can smell the stench clear up at the front office. When I first moved in here in May of 2004, the sewer plant had a sweet smell, I am guessing from some sort of chemicals. Our water/sewer bills back then were around \$35.00, total. Now my bill is around \$77.00 a month and the plant smells awful and the drinking water has gotten worse. If we water our yard in the summer the bill is around \$100.00, and our yards are extremely small.

It is obvious that Labrador has done nothing to improve either the water quality or the treatment plant with the increases that you awarded them a couple of years ago and now you give them an interim increase with a permanent increase to follow. Shouldn't they have fixed prior problems before the interim increase was given to them. I personally think that a water/sewer bill of \$77.00 a month is outrageous and totally unjustified.

In addition to the above, there are 4 empty lots in front of the sewer treatment plant and 3 houses for sale. No one is even interested in the homes or sites because of the odor of the plant and the appearance. This is causing our complex to lose revenue from those 4 lots and the residents are unable to sell their homes. Obviously at one time several years ago when the water/sewer bills were around \$35.00, homes around the sewer treatment plant were sold or there wouldn't be anyone living there now. After Labrador took over it is as though their company buys up mobile home park water works for not much money and then raises the rates every year or so but does nothing to improve the systems they bought. Maybe on paper the audits show they spend money to fix things or improve on things, but if you actually talk to the residents of the park, we see with our own eyes that this work is not really being done. Someone at Labrador is trying to pull the wool over the eyes of the Public Works Dept. Someone should really look into the way Labrador does business.



RATES NOT ADEQUATE FOR CITY'S GROWTH

By NICOLA M. WHITE The Tampa Tribune

ZEPHYRHILLS — It's happening.

The long-discussed water and sewer rate increase moved closer ' to implementation Monday night.

A consultant told city officials that to accommodate growth and encourage water conservation, Zephyrhills must boost its utility rates.

A recent multimillion-dollar expansion of the wastewater treatment plant lends urgency to such a move.

"The rates are not going to be adequate in the near future," said Henry Thomas of Public Resources Management Group.

The consulting firm recommended the city increase water rates by 3 percent each year for the next four years; and

raise sewer rates by 25 percent for the next two years, then 3 percent for every year thereafter.

For most residents — the average utility customer uses 4,000 gallons of water and pays \$23 per month — bills would go up to about \$26 per month, Thomas told the city council.

It's been a decade since Zephyrhills raised its rates. Even with a boost, those charges still would be among the lowest in the area, he said. Among Tampa Bay area cities, the average is \$40.22, with Oldsmar the most expensive at about \$55 a month.

Zephyrhills is the least expensive, followed by Tampa, Thomas' research shows.

The council decided to hold a workshop on the rate issue at 5 p.m. Nov. 27 at city hall, 5335 Eighth St.

This is a follow-up to the meeting that was held by the Public Service Commission in Forest Lake Estates on November 2, 2006.

On October 31-06 we arrived back in Forest Lake Estates and turned on our water.

We did notice that a new meter had been put in. The water came on as planned.

The following morning we got up to the meter leaking. It was filling the meter box. A call was placed to Labrador Utilities on November 1 and we were told that there had been a lot of problems and the man was very busy and he would get to us either that day or the next.

On November 2nd we went to the meeting with the Public Service Commission and upon returning home, we found that the water was now flowing down the street from our meter. (Dated Pictures are enclosed)

On November 3, Labrador was called again. (See enclosed Vonage Phone Print out) Calls are circled.

We were told at the point that the man had been here but didn't have the parts and would have to order them and it probably wouldn't be until Monday. Once again, Monday came and went and still no fix. The service man came on November 7 and fixed the problem. I have been coming to this state for a number of years and have lived in South West Florida and know that water is scarce. Since Nov 1 Labrador allowed the water to run down our street 24 hours a day until November 7/07.

When I was speaking to a girl (Debbie) we discussed the new meters and I asked the question why didn't they turn on the water to test them at the time of installation? She said that is what they should have done. She also told me not to call unless I had an emergency because I wasn't paying for the water that was running down the street, it was the responsibility of the Utility Company. It may be the responsibility of the Utility but we as customers are paying for it in the long run. And waste is not an option.....

Well, it cost money for them to treat and purify that water (Even if you can't drink it) and that is total neglect on their behalf. I am also enclosing pictures that are dated of most of the days that the water ran down the street.

If the Public Service Grants an increase to Labrador with all the problems that this park is having, you are only rewarding them for bad behavior and poor business practices.

People shouldn't have to buy water purifiers and filter systems when they pay dearly for water that is suppose to already be purified. I'm sure that you saw the filter that came off a home that day at the meeting. I'm also sure that you or your family would not want to have that kind of water running through your pipes. Stop and think about that. People are coming in here buying homes and probably none of them have ever asked about the water. We didn't and we are only here 3 years. Would you like to live here?

It is time that the Public Service Commission told Labrador that there is a cost of doing business and until they clean up their act and become a good corporate citizen there will be no more increases.

Have you lost your mind! I haven't been in this state 2 years yet and I'm	n so deep in debt from

constant increases in everything.

Let's get to the water. When I bought my house (trailer), I was told water was \$15.00 a month. Before I moved in, it was increased, on a trial basis, after a year I got a letter stating the increase was permanent. At that time, after the first two bills, I pulled out all the flower beds. They were around the entire house and needed water. You now get to look at lighthouses-they don't need water. My inground sprinklers have been turned on since then. The grass will just have to make it on it's own.

Now I get a letter saying the rates are going up again! Something is not right. I live alone and am a conservationist by heart and have never overused anything and the bills are outrageous. I have attached a copy of what I have paid for water the last 6 months totalling \$349.34. And I live alone! In this six month period, I was gone for 3 weeks. I have talked to other residents of other cities and no one pays what we pay now. Hudson pay \$10 per month for a house. People in this park are doing unhealthy things to keep the cost of water down. Some are only flushing their toilets once a day, some are not showering but once a week (and they are not washing at the sink in the interim). They don't wash their dishes, just rinse them off. These people are on fixed incomes and are struggling to survive. Me included.

Now you are raising the rates again. You really need to encourage the water company to find other ways to meet their financial problems. One of the counties are giving shower heads that conserve water. Maybe the company needs to forget raises and bonuses like many companies have to do. I had a water leak at the meter on a Sunday. I called. They called me back and said someone would be out that day. On Monday they showed up. So for 24 + hours the water just ran into the street. It was on their side of the meter. If they had someone fix it on Sunday,

instead of Monday, that would have decreased their expense. They had someone on call and had to pay him anyway. How many incidents like that occur? Where is that type of expense listed when they come to you for increases. Companies are getting really good at creative accounting and can show you anything they think you might want to see to get and increase in rates.

As a commission, I thought your job was to keep control of rates and be an advocate for the consumers. Is that true? If it is, why when a company asks for \$4, you approve \$7? I would think you would approve less not more!

You are scheluded to be in the park in Nov. That was done the last time and it was like we were talking to deaf ears. It's time to wake up and smell the coffee. This water company is getting enough from this park. NO increase should be approved. The snow birds are paying \$18.00 a month when they are not here and are not using water. Get that number, about 60% of the residents and total the money the water company is collecting for nothing. That amount should help with their finances.

As you can see, I have had enough. It's time you took your job seriously and became a consumer advocate, It's time these utility companies started operating like a person and lived within their means instead of a government, that lives above their means with the attitude we went over budget, we'll just raise the rates!






To Whom It May Concern:
