



**BELLSOUTH TELECOMMUNICATIONS, INC.'S
REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code and Section 364.183, *Florida Statutes*, files this Request for Specified Confidential Classification.

1. On September 17, 2007, AT&T Florida filed a *replacement copy* of Hearing Exhibit No. 15 which contained AT&T Florida's Confidential Responses to Staff's audit requests. Portions of these documents have already been protected under two separate Requests for Specified Confidential Classification filed on November 13, 2006 and December 13, 2006. A Notice of Intent to Request Specified Confidential Classification was filed on September 17, 2006 for the remaining documents that were not protected under the two previously filed Requests for Specified Confidential Classification.

2. Pursuant to Rule 25-22.006, AT&T Florida hereby files this Request for Specified Confidential Classification because the above documents contain information considered confidential business information related to the competitive interests of AT&T Florida that is proprietary to AT&T Florida. A more specific description of this information is contained in Attachment A.

3. Public disclosure of this information would cause competitive harm to AT&T Florida and provide competitors with an unfair advantage. The information

discussed in this Request for Specified Confidential Classification is valuable and AT&T Florida strives to keep it secret. Therefore, such information should be classified as confidential business information pursuant to Section 364.183, *Florida Statutes*. In addition, portions of the information are considered customer account records pursuant to Section 364.24, *Florida Statutes*. Accordingly, the information should be held exempt from the public disclosure requirements of Section 119.07, *Florida Statutes*.

4. Attachment A to AT&T Florida's Request for Confidential Classification contains an explanation of the proprietary information along with a list that identifies the location of the information designated by AT&T Florida as confidential.

5. Attachment B to AT&T Florida's Request for Confidential Classification is redacted copies of the document containing the confidential information.

6. Attachment C to AT&T Florida's Request for Confidential Classification is a highlighted copy of the document containing the confidential information.

7. The original of this Request was filed today with the Office of the Commission Clerk and a copy was served on the Parties.

WHEREFORE, based on the foregoing, AT&T Florida respectfully requests that, pursuant to Section 364.183, *Florida Statutes*, the Commission enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure.

Explanation of Proprietary Information

1. This information contains confidential, proprietary business information of BellSouth. BellSouth strives to keep this information confidential and not publicly disclose the information. This information contains detailed budget, financial and strategic information for BellSouth. Disclosure of revenue accounting and business costs could give competitors a clear picture of the resources required to provide services. Knowledge of such resource requirements could harm the competitive interests of BellSouth.
2. This information contains drawings and information of BellSouth's network. This information is considered to be proprietary and confidential business information. Public disclosure of this information would impair BellSouth's ability to keep the communications network secure. This information is valuable, it is used by BellSouth in conducting its business and BellSouth strives to keep it secret.
3. This information contains confidential, proprietary business information of BellSouth and third-party vendors. In particular, this information contains prices that AT&T Florida has negotiated with specific vendors. The subject information lists these prices, frequently discounted, that AT&T Florida receives on particular items of equipment. If this information were publicly disclosed, it would impair AT&T Florida's ability to obtain favorable discounts in the future. BellSouth is contractually required to keep this information confidential and not publicly disclose the information.

Florida Statutes Section 364.24, provides that "any telecommunications company shall not intentionally disclose customer account records except as authorized by the customer or as necessary for billing purposes, or required by subpoena, court order, other process of court, or as otherwise allowed by law."
