Pursuant to Rule 25-22.058, Florida Administrative Code, the Citizens of State of Florida, by and through undersigned counsel, request the opportunity to present oral argument on Citizens' Motion for Reconsideration of Order No. PSC-07-0816-FOF-EI (Order) which accompanies this request.

Oral argument will aid the Commission in comprehending and evaluating the points raised in Citizens' motion, in which Citizens assert the Commission overlooked or misapprehended evidence of record which, when viewed properly, establishes that the Commission understated the basis for the refund requirement that it imposed on Progress Energy Florida in the Order. Because the factual matters treated within the motion are complex and the impact of the motion on the size of the refund is significant, Citizens submit that oral argument on Citizens' motion is warranted under the circumstances.
