



**TO CUSTOMERS OF O&S WATER COMPANY, INC.
AND ALL OTHER INTERESTED PERSONS**

November 15, 2007

Notice is hereby given that pursuant to Order No. PSC-07-0813-TRF-WU issued October 10, 2007, the Florida Public Service Commission approved the collection of a \$73.00 deposit for all new customer accounts. For current customers, the Public Service Commission has approved the collection of a new or additional deposit when a current customer, in the preceding 12 months: (a) made more than one late payment of a bill (after expiration of 20 days from the date of mailing or delivery by the utility), (b) paid with check refused by a bank, (c) has been disconnected for nonpayment, (d) at any time tampered with the meter, or (e) used service in a fraudulent or unauthorized manner. Current customers will not be charged a new or additional deposit unless they come under one of the preceding categories. For those customers who come under one of the above categories, the utility may require a deposit equal to the average actual water and/or wastewater charges for two billing periods.
