personally identifying information and ensuring that procedures align with state and federal credit and privacy laws.

- 4. PEF is seeking confidential classification for portions of the FPSC's Review of Customer Data Security of Florida's Five Investor-Owned Utilities, PEF Responses to Data Requests 1 and 2, and information contained in Staff's audit workpapers. A detailed description of the confidential information at issue is contained in confidential Exhibit A to PEF's Request for Confidential Classification and is outlined in PEF's Justification Matrix that is attached to PEF's Request for Confidential Classification as Exhibit C. PEF is requesting confidential classification of this information because it contains sensitive business information, the disclosure of which would impair the Company's efforts to maintain confidentiality of its internal processes and security procedures.
- 5. PEF has in place internal processes and security procedures to protect PEF customers and the information they provide to establish an account. In order to obtain such information, however, PEF must be able to assure customers that sensitive business information, such as their social security numbers, will be kept confidential. With respect to the information at issue in this Request, PEF has kept confidential and has not publicly disclosed the confidential information included in the FPSC Review of Customer Data Security, PEF responses to Data Requests 1 and 2, and Staff's audit workpapers. Absent such measures, the Company would run the risk that sensitive business information that customers provide to PEF could be made available to the public and, as a result, could lead to adverse consequences for our customers.

- 6. Additionally, the disclosure of confidential account information, could adversely impact PEF's business interests. If such information was disclosed to the public, PEF's efforts to maintain the security of customer's account information could be compromised.
- 7. Upon receipt of confidential account information from customers, strict procedures are established and followed to maintain the confidentiality of the terms of the documents and information provided, including restricting access to those persons who need the information to assist the Company, and restricting the number of, and access to the information. At no time since receiving the information in question has the Company publicly disclosed that information. The Company has treated and continues to treat the information at issue as confidential.
