This claim of confidentiality was filed by or on behalf of a "telco" for Confidential DN\_112-1-0. The document is in locked storage pending advice on handling. Intrado Communications Inc. ("Intrado"), by its attorneys, pursuant to Section 364.183(1) of the Florida Statutes hereby claims that certain information provided in its Petition for Arbitration ("Petition") contains confidential and proprietary business information that should be held exempt from public disclosure.

Intrado makes this claim because, during the course of the interconnection negotiations between Intrado and BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T"), the Parties signed a non-disclosure agreement regarding the exchange of information during the CMP negotiation process.<sup>1/</sup> AT&T has provided all information to Intrado via email, which contains a COM standard claim that all communications from AT&T are confidential and subject to the nondisclosure agreement. Such information is generally subject to review by regulators and legal DAT CTR authorities in interconnection arbitration proceedings and disclosure of such information is a requirement under Section 252(b)(2) of the Act and Florida law.<sup>2/</sup> The non-disclosure agreement.
