

**MOTION OF AT&T FLORIDA FOR EXTENTION OF TIME TO FILE BRIEF
AND TO ACCEPT BRIEF AS TIMELY FILED**

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T") hereby requests the Prehearing Officer to grant a one-day extension of time to file its brief in the instant proceeding and to accept the brief as timely filed. Pursuant to Order No. PSC-08-0402-PCO-TP, briefs in the instant proceeding were to be filed on June 26, 2008. AT&T timely prepared and attempted to file its brief with the accompanying attachments on June 26, 2008 at approximately 4:34 p.m. The brief and its attachments were received by the Commission. However, AT&T received an email back from the Commission indicating that the filing was rejected by the Commission as being in excess of 100 pages.

The instant proceeding is being conducted pursuant to agreement of the parties as a "paper proceeding" based on briefs of the parties and subsequent oral argument, there is no typical record that has been compiled by the Commission to which to a party's brief can cite without also including a copy of the referenced document. Accordingly, AT&T attached a number of documents to its brief upon which it relies as part of its arguments in its brief. Apparently the page total of AT&T's brief and the attachments exceeded the total page limit of one hundred pages.



In conjunction with the instant motion, AT&T is also refileing its brief with the attachments in the proceeding.


