On April 1, 2008, Regency Utilities, Inc. (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for original water and wastewater certificates and authorization to charge rates. The Commission approved proposed water and wastewater rates by Order No. PSC-08-0611-PAA-WS, dated September 22, 2008. The proposed action became final on October 21, 2008.

The Commission-approved rates and charges were designed to allow the Utility to recover its reasonable and prudent costs for providing service, and an opportunity to earn a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service.

The newly approved rates for water and wastewater service, and the approved revised miscellaneous service charges are attached to this customer notice. The rates and charges are effective for service on or after October 31, 2008.

The new rate structure consists of a base facility charge ("BFC") by meter size and a gallonage charge per 1,000 gallons of water used. Costs included in the BFC represent the Utility's fixed monthly operating costs. Costs included in the gallonage charge represent the Utility's variable cost based on the amount of water used. This rate structure is considered a conservation rate structure by the Commission.
