Re: DOCKET NO. 080724-EU - Joint petition for approval of territorial agreement in Marion County by Ocala Electric Utility and Progress Energy Florida, Inc.

Dear Messrs Burnett and Gilligan:

This data request will assist the Commission staff in preparing its recommendation on your Joint Petition to Approve Territorial Agreement between the Ocala Electric Utility and Progress Energy Florida, Inc. There are 3 composite attachments to this letter to assist you in responding to this data request. Attachment A (consisting of Indexes 1-10) are the maps included in Order No. PSC-98-0443-FOF-EU, issued March 30, 1998, in Docket No. 971543-EU. During 2002 and 2004, there were discussions between Commission staff, the City of Ocala and Progress Energy Florida about discrepancies between the maps on file at the Commission and the maps used by the city. The maps used by the Commission are those in Attachment A. The maps used by Ocala and given to Commission staff in 2002 are in Attachment B and do not include legal descriptions. Attachment C (consisting of Indexes 1-10) are the maps included in the current petition.

1. There appears to be differences between the three sets of maps. For instance, Indexes 4, 8, and 9 of Attachment C are different than those included in Attachment A. Which of the three Attachments accurately represent the service territories?
2. If Attachment B accurately represents the service territories, please give the legal descriptions for each index.


